Please also be advised that the law does not differentiate between coins, tokens, slugs, etc. A slot machine (or video poker type machine) is illegal in your State of residence whether the machine takes coins, tokens, slugs, or any other item. Laws change. We are not responsible for any errors. The previous list is only a guide. Although every effort has been made to assure the accuracy of the previous information, it does not have the force and effect of law, rule or regulation. Should any difference or error occur, the law will take precedence. (Please research your state and local laws before buying any slot machine.)
